We had great weather (no surprise. Since it was AFTER the 4th of July!) for both Saturday and Sunday.

The range was in good shape on Friday when I arrived for set up with a couple of the north-facing bays being used by members for practice, but they were finished well before we got to those bays for set-up.

My thanks go out this month to Jus Dan D (Dan Dupertius) for designing the stages for both days based on the movie "Big Jake", and to him, Half Fast Smitty (Dan Ferreira), T-Bone Shorty (Terry Sporrong), Knucky McPolack (Steve Polack), Dastardly Dean (Gary Sandwick) for helping with set-up

on Friday afternoon, I'd also like to thank Margarita Villian (Kevin Michellich) and Dastardly Dean for handling the scoring chores on Saturday and Sunday, respectively.

We had 26 shooters, three of whom were new shooters on Saturday, and 25 come out to play on Sunday.

We had one match DQ on Saturday when a shooter slipped and fell, and one of his pistols fell out of the holster while loaded. He was not seriously injured, nor was anyone else.

Congrats to our Juniors at the 2019 SASP NW Regional Championships on June 8, 2019.


Senior Varsity won first place in iron sight pistol and rifle Open and Junior Varsity won 1st place in Optic Rifle.

3. Hunter Sight in assistance – Ken Wong updated the following, which was approved:

Hunter Sight In Event at RFGC

Every year, there is an influx of people utilizing the rifle range to sight in rifles for hunting season. This event is aimed at providing the infrastructure to alleviate the high traffic while giving non-members more value for their range use fee.

What: Expedited full-service rifle sighting in

Where: Rifle range, bench 4-6 (3-7 only if needed)

When: The two consecutive Saturdays (and Sundays if there are enough volunteers) prior to hunting season

Who: Experienced volunteers (at least 3 per day)

The Hunter Sight In event at RFGC will provide an economical and efficient way for non- member hunters to sight in their rifles for the season. For \$5 per rifle (instead of the regular \$20 range fee), a hunter will be able to come to the range and sight in their rifle. Once sighted in at their choice of 50, 100, or 200 yards, they must leave or pay the regular range fee and continue on another bench.

There will be volunteers to on hand to expedite and provide basic assistance to hunters. Basic assistance includes spotting targets, bore sighting, mounting of common scope systems, and general troubleshooting. There will be basic tools and spotting scopes available for use from the club and volunteers.

Member hunters may be provided all the benefits of the event for no charge.

- 4. Defibrillator was installed in the action bays. We will not order a trauma kit.
- 5. Wall fan for the table saw in the pistol range. Sam will make some inquiries

#### **New Business:**

- 1. Safety items:

- 2. Austin Smart's complaint against the shotgun Rangemaster. After discussion, Sam will respond to Austin.
- 3. Minors left on the range: This came up after a minor was left at a USPSA match. It's up the match director to make the decision as to whether they can participate.
- 4. Diana submitted a proposal for general membership action bay use:

  This proposal would establish scheduled action bay use by members who otherwise would not have bay use.

The following proposal would not affect the current use of action bays by RSO II members during range hours or after hours.

Members in good standing would attend a one-time orientation class, exact structure to be determined by Action Bay Committee, consisting of class time and hands-on time in the action bay. Classes would be offered on a monthly/every other month basis, tbd.

Action bays would be open to these members only, during range hours only (hours may change dependent on time of year) and on scheduled days only.

Action bay use would be a fixed day or days of the week, minimum 2 days per month.

Only limited bays would be available for use, possibly bays 1-3.

RF&G would hire an additional range master to work in the action bays on the general membership days. Volunteer range officers may also be asked to help.

Targets can be provided by members or can be put out by range master in the am for members to use, either steel or paper. Members would not have access to the targets or TCU directly, only range master or volunteer/discipline chairs.

5. Karen asked about adding cameras in the action bays. Sam asked the action bay committee to consider them.

- 6. Georgia is following up with instructors at the range and has started consolidating rules for instructors. She asked for input from anyone is interested.
- 7. Sam is still looking for part time help at the shotgun range. He tried a trial with Zip Recruiters, which did not work out. An employment button will be added to the RFGC website.
- 8. Roy invited the Board to the Monday Crew BBQ, July 29th
- 9. August board meeting will be on August 8th
- 10. Action Bay Committee (Derek, Sean, Scott & Robb) met on July 1<sup>st</sup> and discussed the following items:

- B. Keeping the brass and steel picked up Sean to follow up with Glenn on the status of Vince.
- C. We agreed to document any incidents or infractions and bring them back to the committee for discussion and possible discipline. An example is a RSO having their entire family shooting in the bay without signing them in
- D. Remind Jim about rule number five Robb sent him an email

Our action bay rule use number five states that a lapse in membership negates the RSO II qualification.

If you get any members renewing now that had the qualification, please ask them to remove the sticker and ask them to contact their appropriate discipline chair.

Please also take them off the RSO II list

E. Charging non-members for official practices

In the past, the board allowed Brian to not charge visitors for the Friday night cowboy practices. Derek would like to continue that.

After discussion, we came up with the idea of not charging for their first visit, but charging \$5 for each practice after that. We need to decide if that is the way we want to go and probably get the Boards' approval.

F. Due to the problems we are having with people not following the rules, we felt that it would be time to conduct a RSO recertification

The idea is to conduct recertification sessions every two calendar years. Robb felt that we would need to issue a new RSOIII sticker so that it would be easy to see who had been recertified. Anyone not going through the session would be decertified. More discussion needs to take place.
