Late Fees

Members who renew late, pay a late fee of \$15 per month to a maximum of \$60. The maximum for seniors would be \$45. Example: a standard member renewing on September 1st will pay \$190

Members who decline to pay their late fees will have their membership cancelled. They may reapply for membership on July 1 (next membership cycle).

NOTE: All members may be assessed an amount, not to exceed \$40.00 per year per membership, over and above the yearly dues, towards any major capital projects with a cost of \$20,000 or more that the club is planning. The membership would be notified no later than April of each year if such an assessment is due.
