IDPA, Scott Johnson:

The most recent IDPA Match was held on January 21st, Shawn Hallinan was the Match Director and he reported: It was a great match today, albeit wet, snowing, and cold. There were 7 full stages that included shooting from retention, engaging multiple moving targets, dominant and non-dominant hand shooting. Target bagging was required after the first two stages. Jon Stein conducted the New Shooter orientation. The shooters meeting started immediately following the Safety Officer walk through. The match started approximately 10:10 AM. There was a total of 38 shooters, 4 of which did not finish. There were no DQs, no injuries and no safety violations. Ben locked the Conex upon securing all props and tools. All the bays were cleared, walls stored on racks, stands stored on pallets and barrels stored in the safe area near bay 3. All trash was emptied, and unusable targets disposed of. Two shooters occupied the Action Bays as we departed, so we did not put the chain across the action bay entrance. Scores were posted to PractiScore immediately upon match completion.
