Rifle range business picked up during the first part of the month. We had 566 members, and 581 guests for a total of 1,147 shooters. The Rifle & Pistol ranges brought in a total of \$9,762.67 for the month.

Jim Newman is looking into getting new signs for the front gate and both range offices showing the new winter hours for each area respectfully. The new hours have been posted on the web site.

Black Rifle had a total of 24 shooters for our annual Halloween shoot. The club took in \$295.00.

All had a good time and there were no safety violators. I left early due to illness but Ken took over and ran it smoothly till it ended.

The next match is scheduled for November 24th. Thanks again for USPSA for sharing their set-up time with us.

# Action Shooting International (ASI), Sandy Wylie:

Ivan Fowler was the Match Director. He reported that there were 66 registered shooters and 4 staff. There were three garbage cans that needed to be emptied upon arrival and all cans were emptied after the match. The Stat shack was cleaned, counters cleared, tapers stored, timers stored. He also picked up about 25 live rounds as he passed through the five bays that were used for the match.

\$942 was turned in to RFGC

There were some RFGC members still shooting in Bay 1 when he left.

# **Old Business:**

- Update on the block walls in the action bays. Still waiting on the supplier. It's a slow time for the company. When there is enough, they will be brought out.
   We will look at placing them later in the Spring when it dries out.
- 2. Sean will research adding something on the membership and waiver forms asking if they are a felon. The waiver has a similar statement so it does not need to be updated. Gary Emerson had a suggestion on the wording. There was discussion regarding how long the waivers should be kept. It was decided that they should be kept for 30 days.
- Committee of Diana, Ken & Sean brought a proposal to the board regarding donations to individuals and youth charity programs.
   The board will review and provide feedback via email. Discussion will continue at the next meeting.
- 4. Discussion continued regarding the email from Bob Louser about shooters, under 18 coming to the range with firearms. State law does not allow them to shoot unless they are brought by their parent or legal guardian or they are a member of the club.
- 5. Discussed load levels as a public range. Wayne will research the issue.
- 6. Scott Johnson presented an updated set of action bay rules. *MSP* to accept the updated rules as submitted.

# **New Business:**

1. Safety items: Glenn mentioned distortion on the rifle range speakers. Steve will look into a solution.

# 2. Request from Scott Johnson:

This is a request for use of 2 or 3 Action Bays, date to be determined as space is available working around and with existing events, in the month of March or April. As part of the men's' ministries at East Renton Community Church we would like to do a "6th Introduction to Handguns" with the opportunity to shoot from both a static firing line and in a low level of competition. We are not charging a fee for the class, but if there is a fee for the Action Bays we will gladly pay the club. I do want to thank the club for the previous times we have been given in 2007, 2008, 2010, 2014 & 2017. I will have each participant sign the usual waivers and I will incorporate the IDPA New Shooter Orientation with added emphasis on Safety & muzzle control. I anticipate that we will have ~30 participants. Several of us are members of RF&GC & 2 of us have been Safety Officers in IDPA for ~18 years.

# 3. Request from Scott Johnson

On August 16th we hosted a Body Armor Demonstration for local police agencies. Also present was the Glock Law Enforcement District Manager Dave Mallery. At lunch, I had a discussion with Dave about GSSF & the possibility of holding this match at RF&GC. Dave gave a positive observation to this possibility and will be a supportive advocate for RF&GC. GSSF is a "Glock ONLY competition".

Another Club member Jon Stein & I have discussed this over the last several years and have been meeting more recently to work out the details of conducting this match.

This is a request for permission to continue working out the details, most likely aiming to conduct this in June or July 2019. It is a 2-day Match that can probably be totally conducted in the Action Bays. Parking may require more room.

- 5. Kevin Michellich asked for the use of the range for Westmatch on Aug 1st through Aug 4<sup>th</sup> *MSP* to approve his request.

6. Sam asked if the board would be interesting in having a potluck at the December meeting. Karen volunteered to organize the event.
