Amendment Changes to read as follows, (changes are added in bold print and underlined).

ARTICLE V: Election of Directors and Officers

Section 5. All full members must have attended at least two (2) Board or membership meetings in the previous eleven (11) months to be eligible to vote on amendments to the by-laws, or to vote in the annual election of officers. <u>Exception, All RF&G Club Life Members along with full time</u> employees, will have full voting rights without the two required meetings.

Of the members present that were eligible to vote, 16 votes were needed to obtain the two-thirds (2/3) majority needed to pass. 15 voted yes so the proposed change did not pass.

# 5. Renton Steel Dragons Proposal

The board was in full support of the proposal.

### Objectives:

- Build upon the incredible history and success of the Renton Steel Dragons.
- Increase local participation Develop a local SASP league with nearby ranges.
- Have squads in each of the 3 age divisions (rookie, intermediate, senior).
- Have fun, model sportsmanship, responsibility, teamwork, and above all teach safety.

League: There are a few teams in Washington state that participate in the Scholastic Action Shooting Program (SASP), which is a great program for youth. As the new coach for the Renton Steel Dragons I'm looking to expand participation locally in order to create a more fun and engaging experience for the youth athletes.

Currently to compete, the kids participate in matches held by the ranges on Saturday or Sunday. These matches, since there are many participants, take up most of the day. We will still encourage participation, but for many of the younger athletes it is just too long, there is too much downtime between stages, and the kids lose interest.

Thus, a league with matches (one-on-one contests) that are 1 ½ to 2 hours in duration, that could be held at convenient times such as evenings, makes sense. These matches prepare and lead the athletes to and through the local, regional, state, and national championships.

Schedule: There is flexibility with both schedule and league format....but a logical sample schedule looks like this.

- Now through February Promotion and team development
- March Season start, practice begins
- April through May League matches
- Early June League Tournament
- Late June SASP Washington State Tournament
- Mid July SASP National Tournament

The Renton Steel Dragons would like to hold practice on Wednesday evening for the Senior athletes and Friday Evening for the Rookies and Intermediate athletes commencing in March.

Depending on the success of league development, the Renton Steel Dragons would like to host matches on either the Wednesday or Friday evening, and reserve the other day for practice. Occurring April through May.

Again, depending on the success of league development, the Renton Steel Dragon would like to host a league tournament – early to mid-June.
