Commentary

The club's financially positive streak continued into November even though revenue dropped by almost a third and expenses rose by 6%. The club was still able to generate positive net income but just barely. However, we are in a good position going into the usually lean months at the start of the calendar year. The club benefited from the generosity of Bill Freyfogle whose donation of \$5,000 was almost a sixth of our revenue for the month. The club also made a charitable donation on behalf of USPSA which increased our expenses for the month.

The club recorded \$30,327.09 in revenue and generated a net income of \$3,034.44 for the month.

Revenue Report

Despite falling 32% compared to October, merchandise sales were the largest component of revenue in November. They accounted for 25.7% of our revenue. As merchandise sales carry a direct cost for us, they are not an optimal primary source of revenue. One bright spot was that match revenue was up 12% from October helped by a strong showing from ASI and revenue from a Black Rifle League match. Membership revenue was down 59.8% from October but was still our second highest source of revenue for the month comprising 18.2% of our revenue. This is a great positive indicator of public interest in our club. Unsurprisingly for a month with less-than-ideal weather, Rifle and Pistol revenue was down 61% from October and Shotgun revenue was 30%.

Grounds, LaMarr Hood:

The Maintenance Crew of volunteers, consist of thirteen Lads and 1 Lady, coming out when they could and some on both Monday and Tuesdays. Hats off to them with a world of thanks. Without their help the range wouldn't be what it is today. As it is they had very good year, major projects were completed mainly lighting the action bays and the rifle ranges, changing the berms by bays 4 & 5, removed trees that were a hazard to the range and neighbors, along with general clean up and maintenance around the range grounds, keeping the rifle & pistol ranges with target backers and stands.

With the rain we were not able to compete the pistol range berm and action bays 4 & 5 side berm. Also do to the covid, Steve was not able to rent the equipment needed to complete the buildup to raise the berms between the action bays and rifle and pistol ranges. With the dirt that has been coming in we have plans to add this dirt to those berms and are in the process of making more parking a south side of the road by the skeet field.

In the month of December, the lads moved more dirt around and kept up with the target backers, cleared the culvert, cover faucets, build up target backers, general clean up, replaced burned out lights and cleared snow from the road and got the shoot gun fields ready to go, removed snow from the canopy covers in the action bays, Thanks for the help, Ted, Scott, & Robb W.

If anyone has ideas for improvements or things that just need to be done have the list forward to me and I will be glad to add it to my list, we do try to work the list but sometimes priorities come up the list seems to be forgotten but it isn't. May the New Year be good to all of you and thank you for your support.

New Business 1/6/22

To the RFGC Board

I am the Chair of the Washington State Sportsman's Caucus which is part of the National Association of Sportsman's Caucuses and connected with the National Shooting Sports Foundation. The association is made up of both National and State Legislators with the mission of encouraging and protecting Hunting Fishing and Trapping. We recently held our National Conference in Little Rock AR and discussed ways of increasing hunting participation especially by women. On a state level we would like to address:

The double tax on sporting clays – Had a hearing on my bill to renew the sales tax exemption. Very little testimony support. The bill is still live but on life support. Working with DOR to allow the use of resale certificate when purchasing clay birds.

Would like to ask the Club to submit a sales tax refund based on billing the birds separate from the round of trap. Attach the follow explanation.

Renton Fish and Game club understands that the Department of Revenue believes that clay birds are "consumed" during the round of trap and are therefore not eligible for a resale certificate to be used when purchasing. Since ??? Renton Fish and Game Club has billed the clay birds separate from the round of trap. A person pays for the birds, then pays for the round of trap or skeet. A typical round is 25 birds. In some cases, during practice, shooters will shoot more than 25 birds. In that case they pay for each of the additional birds used. Sales tax is charged at the time of payment for the birds separate from the actual round of trap and sales tax is collected on each (See attached receipt).

Attached is a report on the sales tax paid for the clay birds since ??? and the corresponding DOR sales tax reports filed. Please make refund check out to Renton Fish and Game Club.

Encouraging nutrient enhancement to increase salmon runs
