Announcements:

MSP (Motion Second and Passed) by LaMarr Hood seconded by Terry Sporrong to approve the minutes, as revised for April.

The following decisions were made at the April directors meeting:

- 1. To spend up to \$3,000 to install a Unifi Camera system in the action bays (see old business).
- 2. Updated the instructor for profit policy to add an annual renewal requirement (and other minor changes).
- 3. Accepted the bid to replace the front gate with a wrought iron one (see old business).

Archery, Ted Pitt:

The ranges are looking good. Mark found a deal on some used 3d targets. He is repairing them and putting them out.

Trap & Skeet Ted Pitt:

Shotgun is looking good. The grass is kind of growing. We have had 3 bunker shoots so far (all have gone well), the next is May 5th.

Rifle & Pistol, LaMarr Hood:

Range looking good. Our range usage for rifle 407, pistol 482, action bays 185, after hour shooters 17.

Total Members 670, Nonmembers 229, Total 899, Last month 931 down 32. April 14 the busiest day sense Last April with 81 shooters going thought the range, yet last April we had 1083 shooters at the range.

The new target holders seem to be holding up well, except for using 12 gage shotgun slugs that can't be keep on paper.

We are still working to finish the 200-yard line.

Grounds, LaMarr Hood:

The crew at the pistol range, place ground cover on the outside of the cement in front of the firing line to help catch the brass it seems to be working nicely. We been cleaning some of the brass. A lot of the brass picked up at the work party and from the ground in front of the firing line had a lot of dirt and rocks in it and that takes more time that just running through the sorter.

We added more chips to the short pistol berm and are training two new operators for Godzilla.

Our contractor for the water line is coming along and into the action bays.

Friday set-up was a bit wet, but not too bad. The range was in good shape when we arrived.

Our guest match designer, Tuscan Grit (David Galiotti) wrote six great stages for Saturday and six different great stages for Sunday! Thanks to Just Dan D, Jackstraw, Helena Bucket, T-Bone Shorty, and Hardway MacRae for coming out to help git 'er done.

Saturday started with some rain, but got better throughout the day, and the really hard rain came as we were leaving the range!

31 shooters came out to test their mettle against Tuscan's stages, and four managed to shoot the match clean! Mudflat Mike, Appy Dan, Hazy Grey, and Margarita Villain. Our top three shooters overall were: T-Bone Shorty in Third, Bjorn E. Ville in Second, and Mountain Man Dan in First.

Sunday brought 19 stalwart gunslingers out to defend RUCAS territory in a little better weather, and on this day, the steel bad guys had their way with us, as nobody managed a clean match! Out top three on this day were: Once again T-Bone Shorty was Third, Diamond Slinger was Second and for two days in a row, Mountain Man Dan took top honors.

There were no DQ's either day and \$630 was turned into the Club.

Old Business:

- 1. New financial and membership system for the club Georgia Status: New system is working. There is still some background communication that is in work between the systems. We can accept credit cards now, but not the gift cards.
- 2. Pilot for a target retrieval system on the pistol range (short end) LaMarr. Status: No one has been available to work on it.
- 3. New waterline and cable conduit Ted *Status: In progress*
- 4. Labor & Industries visit to observe Ted mowing Ted Status: They watched him mow and monitored him for noise and dust.
- 5. Replacing or repairing the front gate that was damaged by a vehicle sliding into it Ted. Status: The board accepted the \$5,990 bid from AC Custom Metal Work for a wrought iron entrance gate.
- 6. Installing a camera system in the action bays Scott Collins Status: Approved spend up to \$3,000 to install a Unifi Camera system in the action bays. Planning is on progress.

New Business:

- 1. Safety Items for April:
 - a. Nothing to report.
- 2. Renton Crushers made a request for support to attend the Nationals in San Antonio Texas this June. Will be brought to the executive meeting on Monday.
- 3. Request from Diana Pinto: I would like to ask for the use of the rifle and pistol range, as well as the clubhouse, for our annual charity shoot on August 24th. Last year we were approved to use lanes 1-4 on pistol and 3-9 on rifle, and the clubhouse at 6pm *MSP* to approve the request, following the club's facility rental policy.
- 4. Tim Ralston requested the use of the action bays on Sunday June 9th for the "Slay the Dragons" fundraising event.
 MSP to approve the date for the event.

5. Dave McClure brought up the issue of limited parking last Sunday during the USPSA match and the Shotgun event. USPSA participants were parking at the rifle and pistol range which then limits the parking for the rifle and pistol range users. There are already signs at the rifle and pistol range asking action bay event participants to not park there.

Robb suggested that on the day of the match the USPSA MD put a sign up at the entrance to the rifle & pistol range (right in the middle so it must be driven around) stating that the parking there is not for action bay matches.

Suggested signage wording:

NO USPSA Parking Please Park in the woods along but off the road or by the shotgun range.

6. There has been a lot of damage to the range from shotgun slug usage on the rifle range. We believe it from users who do not have sights on their shotguns.



Currently in the membership handbook:

Shotguns are allowed on the 50- and 100-yard rifle range with lead slugs only. Shooters must follow the same rules and guidelines as rifles (there are no other restrictions or limitations).

First Proposed change:

Shotguns are allowed on the 50- and 100-yard rifle range with lead slugs only and must be equipped with a buttstock and either:

- An optic mounted on the shotgun.
- Both front and rear sights properly installed and functional.

Second Proposed change:

Shotguns are allowed on the 50- and 100-yard rifle range with lead slugs only for members only. Shooters (members) must follow the same rules and guidelines as rifles (there are no other restrictions or limitations).

Decision: Will be discussed at the Directors meeting on Monday.

7. How to cover the additional expenses of the 200-yard steel on the rifle range?

Problem statement:

The use of the steel targets on the rifle range at 200-yards is an added expense for the range:

Purchase of the steel

Purchase of paint

Purchase of materials to hang and repair the targets.

Proposal:

- Beginning with the 2024 2025 renewals, all users of the 200-yard steel must pay a \$10 or \$25 annual fee to use the steel (tied to the annual membership renewal period).
- Effective July 1, 2024, a lock will be place on the box containing the 200-yard steel and only shooters who have paid the annual fee will have access to the box.
- Each July 1 thereafter the combination on the box will be updated.

Decision – will be discussed at the directors meeting.

8. Added a new section to the Membership Handbook to address action bay use:

Cowboy matches

Saturday: Actions bays are CLOSED until AFTER the Cowboy match is over (approximately 2:00PM). Approved users may use bays that are NOT set up for the Cowboy match (after the Cowboys leave).

Sunday: Actions bays are CLOSED until AFTER the Cowboy match is over and they have left the bays (approximately 2:00PM).

During Steel Dragon practices others may use the action bays but may be asked to leave if the Dragon's need to expand their practice to that bay. Example: The RSO2 sets up in bay 6 but the Dragons have so many kids show up that they also need that bay for their practice. Please note that Centerfire rifles are not allowed (it's hard to coach with the extra noise).

USPSA setup and matches - No use of the bays is allowed on Saturday. No use on Sunday until after the match is over and they have left the bays (approximately 4:00PM).

IDPA and ASI matches - No use is allowed until after the match is over and they have left the bays (approximately 3:00PM).

9. When LaMarr came in on Monday the rifle range benches and chairs had all been moved (for prone shooters) and not put back to their normal position. Shooters need to put everything back when they are finished (including the sandbags and wood rests).

Good of the order:

Report from the World Cup where shooters were qualifying for the Olympics.
