Announcements:

MSP (Motion Second and Passed) by LaMarr Hood seconded by Tim Ralston to approve the minutes, as submitted for May.

The following decisions were made at the May directors meeting:

- 1. Added a ceasefire process to the membership book and posted an abbreviated version at the pistol range.
- 2. Changed the shotgun requirements when used at the rifle range: Shotguns are allowed on the 50- and 100-yard rifle range with lead slugs only and must be equipped with a buttstock and either:
 - o An optic mounted on the shotgun or.
 - A front sight.

3. Added an annual fee for users of the 200-yard steel.

Situation:

There are approximately 100 members who are qualified and 30 members who consistently use the steel. The use of the steel targets on the rifle range at 200-yards is an additional expense for the range:

Replacement steel (\$1500 in 2024).

Paint.

Materials to hang and repair the targets.

Decision:

Beginning with the 2024 – 2025 renewals, all users of the 200-yard steel must pay a \$25 annual fee to use the steel (tied to the annual membership renewal period).

This fee will be required each membership year.

Only club steel can be used (members cannot bring their own).

Effective July 1, 2024, a lock will be placed on the box containing the 200-yard steel and only shooters who have paid the annual fee will have access to the box.

Each July 1 thereafter the combination on the box will be updated.

Archery, Ted Pitt:

The ranges are looking good. Mark is working on the 3d targets, painting and fixing inserts.

Trap & Skeet Ted Pitt:

Shotgun is going well. Our Mayday shoot went well, we had 4 squads. We have a shoot on June 15th.

Rifle & Pistol, LaMarr Hood:

Range looking good. Our range usage for rifle 481, pistol 559, action bays 205.

Total Members 768, Nonmembers 286, Total 1039. Last month only 899. We were up 140 shooters.

May 19th, we had a high of 91 shooters go thought our ranges.

The highest since I started keeping records in April 2023. Last May we had 1062, 24 more than this year.

On the ranges we have laid down a ballistic tarp in front of the shooting lines. This is to help clean up the brass that get sent forward from the firing line. This makes it easy to use our roller to pick up the brass casings

Grounds, LaMarr Hood:

The crew have been helping with the work at the rifle range and building target backers and general cleanup along with sorting our brass supply. From the target backers stack, we replaced 3 short target legs from the rifle side and 36 long legs on the pistol side with 45 target backer boards total.

We have cleaned out the electrical parts from the two TCUs in the action bays.
