**Announcements:**

**MSP** (Motion Second and Passed) by Terry seconded by Dave to approve the minutes, as submitted for October.

**Decisions made at the October 7th Directors meeting.**

1. Giving donations to political campaigns.  
Decision: No donations to political candidates or parties. We will allow endorsements, and initiatives.
2. Donations requests.  
Decision: Donations may be requested for event costs, but not for firearms or other equipment.

3. Revised the For-Profit Instructor policy to state that payments may be by check or cash. A 3% fee will be added if paid by credit card.
4. 2024 election voting process (no change from 2023):
  1. The Game Warden will send a list of members who are qualified to vote, to the Secretary.
  2. The Secretary will email ballots to all eligible voters, after the end of the November meeting within one week.
  3. Members will add their member number to the ballot and after completing it place in the ballot box at the main clubhouse before 7:00PM on December 5<sup>th</sup> (preferred method).
    - a. If they are not able to place their ballots on the box, they may Email it to: [secretary@rfqc.org](mailto:secretary@rfqc.org) before December 5<sup>th</sup>. Who will print and place it in the box.
  4. The Secretary will provide the approved voting list (with member numbers only) to the club president.
  5. The President selects a counting committee of three members not on the ballot.
  6. The ballots are given to the counting committee
  7. The counting committee members will each count the ballots.
  8. The counting committee will validate the results.
  9. After validating the voting results, they are provided to the President.

Oct. 5<sup>th</sup> & 6<sup>th</sup> match report:

The weather gods were kind to us and gave us two beautiful days for Cowboy Action Shooting!

Saturday, we had 23 shooters come out for a great day of stages written by Tuscan Grit.

There was only one clean shooter in this match, that was Slick. Our top three competitors were: G.D. Rattler in Third place, Rick O'Shea in Second, and Mountain Man Dan in First.

Sunday saw 26 Cowfolk come to do battle with the steel bad guys. Again, only one was able to shoot the match clean, that was Cedar County Sheriff. Out top three shooters were: R&R in Third, Lady T in Second, and Rick O'Shea in First.

There were no DQ's either day and only one Minor Safety Penalty for leaving a live round on the carrier of a loaded rifle on Sunday.

\$675.00 was turned into the Club.

**November's** monthly matches were held in mostly dry and moderate temperatures with guest Match Director, T-Bone Shorty, writing the stages in six bays and leading the match.

Saturday drew 23 competitors, with 1 clean shooter who also happened to be the overall winner, T-Bone Shorty. Rumor was the stages had been set up since Wednesday and he was "practicing" all week. Runner up was Bjorn E. Ville and placing third was Lawbreaker. There were two SDQ's that resulted in a MDQ (two SDQ's earned in the same match=MD, SASS Rules.) The first one was for sweeping with empty firearms, and the second was for moving with a loaded and cocked shotgun. This was a newer shooter, but the good news is he returned on Sunday and had a positive shooting experience with no safety violations the next day.

Sunday drew 24 more competitors and had 4 clean shooters, including Rick O'Shea, Slick Ranger, Mongoose and Freddie Sykes. Overall winner was Rick O'Shea, runner-up was Slick Ranger, and in third place was Mongoose. Evidently it pays to shoot clean! There was one SDQ for a dropped unloaded pistol.

Money Matters- \$675 was turned into the club, (3 comps total for both days)
