### **Standing Committee Reports:**

#### **Archery, Ted Pitt:**

The archery area is looking good now that the trails have been cleared and the leaning trees have been removed after the storm. However, the deer have been roughing up the 3D targets, treating them like real deer.

#### **Trap & Skeet Ted Pitt:**

The shotgun range is going well, and the bunker is in good shape too. We'll be receiving new targets this Friday.

#### Rifle & Pistol, LaMarr Hood:

The rifle and pistol building did not have any problems created by the storm. The lights are all up and working and in general the range is in good shape.

Due to closures (weather), those who come out, Members 504, Nonmembers 229, Total 733, Last month 969 using the ranges. Range usage rifle 404, pistol 371, action bays 81, after hours 10.

We have elected to continue using the new target holders at the 50 & 200-yard lines, due to the cost and time to maintain the target backers. We will continue using the same backers as in the past at the 100 yards and though out the pistol ranges. When a shooter places his target on the target backers,

they need to keep the targets they staple on at least <u>3 inches from the sides</u>. Otherwise, they are shooting out the legs of these targets.

#### **Grounds, LaMarr Hood:**

Ted has been keeping the roads clean off and after the storm Ted and John G. clean off the parking lots and areas around the club and the roads again. We have also kept up with target backers and general clean up in the rifle and pistol buildings along with sorting the brass that has been picked up. We are also cleaning and organizing our storage sheds.

The TCUs are getting completed. Scott has been hard at work in the west TCU and had some help from Robb and Kevin on that one and it is getting loaded. The cowboys got inside of their TCU ready to load up also with their shooting supplies and props. The TCCU's will be completed the first part of December.

  Status: We have the cameras and equipment. Need to schedule a time to conduct the work.
- Website redesign Robb Wolfe
   Status: Feedback on the draft website has been provided by the BoD and is being incorporated <a href="https://alanb215.sg-host.com/">https://alanb215.sg-host.com/</a>.
- 3. Need a banner on the website that notifies people about the hours and closures. Status: We will have that capability with the new site.
- 4. Greg Livell would like to pre-book classes one class a month for 2025. Status: Complete

# **Safety Items for November:**

1. None to report

#### **New Business:**

- 1. Derek asked for approval to purchase a laptop computer for their matches. It was suggested that they come to the ASI match and see how it is done with the tablets and a keyboard.
- RSO2 use of the action bays for practice: A proposal to require a reorientation for the 2025 2026 membership year and then a match participation requirement for the 2026 2027 membership year (determined by the discipline chair).
   Propose that we share it with the membership for feedback and then resubmit at the January meeting.

#### What problem are we trying to solve?

- · Keeping the area clean and safe.
- The privilege of using the bays was intended for active discipline Range / Safety Officers

#### Note:

- This is for practice times and does not apply to sanctioned events / matches (USPSA, ASI, Cowboy, and IDPA).
- Instructors would no longer be given RSO2 status.

#### Situation

- Many users are not cleaning up after themselves.
- Users are allowing rounds to impact the ground (not the berm). Not sure what else may be happening, but we will know more after we have cameras installed.
- There are users who are no longer associated with any of the Disciplines (e.g., no longer an IDPA SO).

#### Proposal / option

- Required re-orientation for all RSO2's prior to the June 2025 renewal.
- Those who don't will lose access after renewal (June 2025). Notify all who
  complete the orientation that only grandfathered members (LaMarr, Karen, etc.)
  and Range Safety Officers who have actively work in four (4) matches at RFGC in
  the next twelve (12) months will have access after June 2026. This will be a yearly
  requirement to retain access and determined by the discipline chair.

#### Next Steps (after approval)

- Notify all current users about the new requirements and the upcoming reorientation
  - Compile and Create an Outlook DL group that contains all the known RSO2 members.
- Schedule re-orientation sessions and make them accessible to all users before June 2025 (start sessions in April).
- 3. Implement a tracking system to monitor participation in RFGC events for RSO2 eligibility
  - a. Leverage the spreadsheet that all discipline chairs have access to.
  - b. Long/medium term, leverage RGP app to track RSO2 members
- 4. Regularly review and enforce cleanliness and safety standards on the action bays.
- 3. There is a speedbump stake that needs to be repaired.
