#### **Old Business:**

- 1. Installing a camera system in the action bays Scott Collins Status: Need to schedule a time to conduct the work.

- 4. Discussion regarding RSO2 use of the action bays for practice: A proposal to require a reorientation for the 2025 – 2026 membership year and then a match participation requirement for the 2026 – 2027 membership year (determined by the discipline chair). MSP the following:
  - Required re-orientation for all RSO2's prior to the July 1, 2025, renewal.
  - Those who don't will lose access after renewal (June 30, 2025).

#### Next steps:

- Notify all current users about the re-orientation requirement.
- Each discipline will schedule re-orientation sessions before July 2025 e.g. ASI will conduct them after each match starting in February.
- At the orientation the discipline chair will record the attendance and provide a new RSO2 sticker.
- New internet provider -Status - Ted is working with Xfinity

#### **Safety Items for December:**

 In December, there was an incident involving a shooter at the short-range pistol line. The shooter discharged a bullet vertically at a 90-degree angle to the firing line. The bullet struck the outer wall above the shooting bench, causing it to hit the conduit and wiring to the outside night lights. Fortunately, the baffles worked as intended and stopped the bullet. The incident was not reported.
