After using the retrieval system, we purchased and finding what problems it had. Rob Laird came to me and said he could build a system that would work for us and cost much less. Roy Rasmussen and Dale Shawley came up with what parts were needed to install Robs system. We received our order of parts for the retrieval system (finally), John & Dale hanged the rails. Next Rob hooked up the cables and stops and motors while Dale and Gary wire in the system. Paul Jackson came in with his tracker



& graveled next to the cement area and brought in the chips to cover the rest of the area under the baffles. Richard Burgess and I spread the gravel and chips. On Monday Oct. 20, members of the Money Crew had fun shooting while testing and christen the new system. On Wednesday 22nd of October the new system was open to the members and paid quest of the range. The system goes out to 40 feet.

I give thanks to all who have helped with getting the pistol building cleaned up and painted and the retrieval system installed & four new shooting benches built and placed on the long pistol range, along with the Board of Director of the Club for approving and appropriating funds for this upgrade and to Robert Laird for his idea and design for the system we install.  - d. The Secretary will provide the approved voting list (with member numbers only) to the club president.
 - e. The President selects a counting committee of three members not on the ballot.
 - f. The ballots are given to the counting committee
 - g. The counting committee members will each count the ballots.
 - h. The counting committee will validate the results.
 - i. After validating the voting results, they are provided to the President.
