## Standing Committee Reports:

### **Archery, Ted Pitt:**

Archery looks great! Mark mentioned that there are a few spots where some wood needs to be removed.

### **Trap & Skeet Ted Pitt:**

Shotgun is going well. The pattern board fence is backup, but we still need to replace one more post.

We have our first bunker shoot of the season on April 4th.

The wood pile area looks awesome after the work party.

### **Rifle & Pistol, John Gerhard:**



Ranges are looking good. The rifle range 50 yd, 100 yd and 200 yd target frames are updated. The new frames show legs forward to discourage shooters from stapling targets over the legs. Exposed rocks have been removed on rifle and pistol range berms. The short pistol range and rifle 50 yd and 200 yd berms were refreshed with wood chips. The red safety line on the rifle range has been refreshed with a red 4" adhesive tape based on a suggestion by Don Miller (CMP). If it wears well with foot traffic, it will be used on the pistol range. The work party really helped finish cleaning up the ranges.



Brass collection: February - 356 lbs.; March - 328 lbs.

Consumables: monthly average remains low for all target systems.

**Grounds, LaMarr Hood:**

First week, we checked out the retrieval system. A new shooter hit and broke a cable. Finalized plan for four new systems which was approved by the BODs. Replaced new target holders at the 50yd line and Gary dressed up berms 50 and 200 and Dale continues wiring the R&P office and is almost completed with this portion of the remodel. Brass was sorted and general clean up.

Then the wind, rain and snow. Scott and Karl Karlson cut up and removed the tree and limbs that worked over the bay 2 loading bench, while denting the berm and finishing in bay 3.

Work party held Saturday 28th. with good weather, we had 66 participants sign in. With lunch provided, thanks to Georgia, a good time was had by those who came out. Lot of old and new work projects were worked on and most completed.
