Treasurer's Report, Georgia Coulter:

Standing Committee Reports:

Archery, Ted Pitt:

Archery is doing fine.

Trap & Skeet Ted Pitt:

Lead mining operations will be taking place on the shotgun fields over the next 3–4 weeks. Work will occur primarily on Mondays and Tuesdays, with work on other days before 10:00 AM and after the shotgun range closes at 6:00 PM. No shotgun fields will be closed, and we do not anticipate any impact on shooters or normal range operations. We appreciate your patience while this routine maintenance is completed.

Hill is being mined and is ½ across trap one. They currently have shot for sale for approximately \$40 a bag.

Bunker is going well. Just received a load of targets.

Rifle & Pistol, John Gerhard:

The rifle and pistol ranges are looking great. New lane markers have been set at 100 yds. They are removable for mowing.

Thanks to Dale and Roy for excellent progress on the electrical work in the range office. Cameras and the PA system remain.

Target systems: During June, repairs and consumables were negligible.

2026 six-month consumables: 43 wood backs; 6 50yd frames; 23 2'x3' plastic backs; 6 retrieval cables; 16 short legs; 35 long legs. The 6-month wood backs and legs numbers are roughly the same as 1-month consumables in the old target system.

Progress has been made on the 25yd target retrieval system on the pistol range. The motor bases are fabricated and end pulley plates installed.

Grounds, LaMarr Hood:

Gary has been working on building up the berm on the short pistol range. The shotgun hole in the roof on a safety Shelter had been patched. Dale added an extra outlet in trap 4 so the sump pump can be turned on also been keeping up with other lights around the range. Other than this the crew has been doing general repairs and clean up on the ranges and bays along with sorting brass.

The SASP State Championship was held June 20 in Custer, where our athletes turned in an outstanding performance. The Dragons earned first-place finishes in their respective divisions and disciplines, continuing the strong tradition of excellence within our team.

We had our annual "Un Hombre Muy Malo" match, with a lot of reloading on the clock, on Saturday along with our regular SASS match.

Saturday was a bit of a challenge weather-wise. We had a light turnout of 10 "Malo" shooters, 9 of which finished the match. Just Nobody was our only clean shooter in this match. Our top three Malo Hombres were: G. D. Rattler in Third Place, T-Bone Shorty in Second, and the fastest Hombre of all was Just Nobody.

There were 9 shooters who came out for the regular match. There was one clean shooter in this match as well, Lawbreaker. The top three were: Jimmy Smits in Third place, Bjorn E. Ville in Second, and Lawbreaker in First.

Sunday's weather was much better than Saturday's, 24 folks joined in to defend RUCAS territory against any and all steel villains and scoundrels, with 23 finishing.

Six stalwarts were able to manage the match clean this day, they were: Slick Ranger, T-Bone Shorty, Jed I Knight, Hardway MacRae, Freddy Sykes, and Mongoose. Our top three overall were: T-Bone Shorty in Third Place, Just Nobody was Second, and Diamond Slinger was First.

There were no Stage DQ's for either day, however Sunday we had one Match DQ for a round fired through the roof of the safety area while trying to clear a jammed shotgun, there were no injuries. An incident report has been turned into the Club Office.

2. Port of Seattle Wildlife Abatement Training Request

The Chairman of the Port of Seattle Wildlife Abatement Program contacted Gary Emerson, one of our Hunter Education instructors, regarding the use of the club for training.

They are requesting permission to use the trap range during normal business hours several times per month this summer to provide shotgun practice for their wildlife removal technicians. They would like to establish a monthly billing account to pay for the trap rounds used during training sessions. If monthly billing is not available, they would like to know whether the club still offers trap range punch cards.

They are also requesting permission to store four to five shotguns at the club between training sessions, as most of the technicians do not own their own shotguns.

Board discussion/decision requested – will be discussed at the Monday Directors meeting:

- a. Approve or deny use of the trap range for training.
 - b. Determine whether monthly billing or punch cards will be offered.
 - c. Determine whether secure shotgun storage can be provided and under what conditions.
3. May need to plan for training for members to follow the new state laws for CPL renewals and purchases.
