INTRODUCTION

Renton Fish & Game Club is a nonprofit sportsman's club that has served the community since 1933. Our mission is to promote conservation and provide members and the public with a safe, welcoming place to enjoy shotgun, rifle, pistol, and archery shooting sports. The club is nonpartisan, and membership is open to individuals of good character who support wildlife conservation, hunting, fishing, and the shooting sports.

Situated on 33 acres, the club's grounds are preserved as a wildlife sanctuary that supports a wide variety of native plants and animals. Throughout the year, the club participates in conservation efforts and operates a native plant holding facility for King County on its property.

Renton Fish & Game Club is one of the oldest and largest shooting ranges in King County. For nearly a century, we have provided a place where people can shoot safely, build skills, and learn responsible firearms handling through a variety of training programs and club activities.

The Board of Directors meets on the first Thursday of each month at 7:00 PM in the main clubhouse (shotgun area). Meetings are open to all members and may be attended in person or virtually.

Code of Conduct

Renton Fish & Game Club (RF&GC) is a family-friendly organization committed to maintaining a safe and respectful environment for our employees, members, and guests. All individuals on RF&GC property are expected to fully comply with the following Code of Conduct—without exception or interpretation. In the event of ambiguity, the Board of Directors reserves the sole right to interpret the Code as they deem appropriate.

General Expectations

- A. Members, Guests and Club Employees must conduct themselves—whether personally or in business matters—on RF&GC property in a manner that is safe, respectful, and considerate of others and club property.
- B. All communications (verbal, written, or digital) with Members, Guests and Club Employees must be polite, respectful, and appropriate.
- C. Members, Guests and Club Employees are required to follow all RF&GC rules, policies and posted hours. Members and Guests must also adhere to instructions from Club Employees. Any disagreements or concerns shall be brought to the Board of Directors for review.

Prohibited Behaviors

The following are examples of conduct that violate the Code. This list is not exhaustive:

- Verbal or written threats.
- Aggressive behavior, including threatening posture or hand gestures.
- Use of loud or aggressive tones, which may be deemed threatening.
- Abusive, profane, or vulgar language.
- Sexual or racial harassment, including slurs.
- Intruding on personal space or inappropriate physical contact.

Consequences

Violations of this Code of Conduct may result in disciplinary action, including suspension or revocation of membership.

General Club Policies

- **Operational Hours**

- The club is closed every Monday and Tuesday, as well as on Thanksgiving, Christmas Eve, Christmas Day, and New Year's Day.
- No discharge of firearms is permitted during club closures except for Board-authorized shooting events.
- Shotgun range hours are 10:00 AM to 6:00 PM from April 1 through October 31, and 9:00 AM to 5:00 PM (or dusk, if earlier) from November 1 through March 31.
- Rifle and pistol range hours are 10:00 AM to 6:00 PM year-round.
- Firearms may not be discharged on club grounds before 9:00 AM or after 8:00 PM.
- The club follows Issaquah School District snow-day closures.
- The property has two controlled-access gates. These gates must remain closed and locked unless authorized personnel are on the premises. Only authorized personnel may access club property during non-business hours.

- **Non-Member Waivers**

A signed waiver is required of each non-member prior to shooting every time they use the range.

- **Wildlife Preserve**

The club grounds are a wildlife preserve. Shooting at or harassing animals on club property is strictly prohibited.

- **Lost or Stolen Items**

Renton Fish & Game Club, its Board of Directors, officers, and rangemasters are not responsible for personal items that are lost, stolen, or damaged on club property.

- **Unclaimed Personal Items**

Personal items found on club property should be turned into the rangemaster. Items will be held for 90 days. The club will make a reasonable effort to contact the owner; however, unclaimed items may be disposed of after 90 days at the discretion of the Board.

- **Range Usage**

Club ranges are open to members, their guests, and the public. During normal business hours, BEFORE entering an active shooting area everyone must sign in at the appropriate range office.

- **Badges**

Members must wear their club badge visibly above the waist. Replacement badges are available for \$10.

- **Range Cameras**
To help maintain safety and monitor for unauthorized access, cameras are installed throughout the premises and record continuously.
- **Safe Shooting Positions**
Firearms and arrows may be discharged only in areas specifically approved by the Board of Directors as safe shooting positions.
- **Unsupervised Children**
No child under the age of 16 may be on club grounds unless under the direct supervision of a parent or legal guardian.
- **Alcohol, Controlled Substances, and Medication**
No alcoholic beverages may be consumed on club grounds during scheduled shooting hours. Anyone who appears to be under the influence of alcohol, controlled substances, or prescription medication that may impair safe firearm handling will be barred from shooting and may be asked to leave at the rangemaster's discretion.
- **Concealed Weapons and Open Carry for Members and Guests (Uniformed Law Enforcement Officers Are Exempt)**
All firearms must be unloaded when entering RFGC property, except for concealed firearms that remain concealed. Concealed firearms must always remain holstered while on club property. Open carry is prohibited on club grounds except during sanctioned matches.
- **Volunteers**
Members who volunteer at least 20 hours during their membership year by supporting and maintaining the club through work parties or other needed tasks are eligible for a discount on membership dues.
- **Member Guest Passes**
Members, excluding juniors, may bring guests using up to six guest passes per membership year. The member must be present with the guest or guests, and everyone must check in at the appropriate range office. Members may also bring additional guests by having them pay the applicable public fees. Membership privileges, such as access to 200-yard steel targets, do not transfer to guests.

- **Training Classes for Profit**

Instructor training programs require approval by the RFGC Board of Directors on a case-by-case basis, and the club is under no obligation to approve any proposed course. The Board reserves the right to review course content, instructor qualifications, and any other aspect of the proposal it deems appropriate. Approval does not constitute endorsement; it only permits the instructor to conduct training at the club.

- **Dogs**

Dogs are allowed on club property unless a complaint has been made regarding the dog. Dogs must always remain under the owner's control and must not interfere with shooting activity. If a complaint has been made, the owner may be asked to no longer bring a dog to the range.

- **Policy Enforcement**

Each member is responsible for following and helping enforce club policies and safety rules.

Anyone who fails to follow the authority or direction of the rangemaster may be asked to leave the range at the rangemaster's discretion. The incident will be documented and reported to the Board of Directors.

Members who violate club policies or safety rules may have their privileges suspended or terminated. The Board of Directors is the final authority on all suspensions and terminations.

CONSERVATION

Habitat Restoration Projects

Renton Fish & Game Club is very active in several local restoration projects, including an ongoing project to improve habitat on the club's grounds. The club purchases and plants several hundred bare-root native plants on club property every spring. Club members also attend salvage projects each year, where they dig and pot native plants from sites slated for future development. Most of the native plants are turned over to the county for use in restoration projects sponsored by King County.

Archery Range Information

The archery committee promotes the safe use of bows and arrows by providing a safe area for target shooting to improve bow hunting or archery skills. Archers may walk the course as many times as they wish.

Renton Fish & Game Club hosts a trail-walk-style archery range. One course has 7 stuffed bag targets, and a second course has 3 stuffed bag targets that vary in distance from 10 to 60 yards.

The archery range exists because of volunteer support from club members. Help is always appreciated. Please contact the archery chairperson if you would like to assist with archery range maintenance.

Archery Range Policy

- All shooters must sign in with the rangemaster before entering either the north or south archery course.
- Crossbows are not allowed.
- Any additional attachment to the bow that allows the draw weight to be relieved from either or both arms is not permitted.
- Overdraw bows must have a protective shelf.
- Blunt-tip arrows are prohibited.
- Broadhead arrows are prohibited.
- Archers must be able to draw their bows without raising the plane of the arrow above the target.
- Archers must have sufficient skill to keep all shots within the target butts.

Archery Safety Rules

- Arrows must remain unnocked and safely stored at all times except when the shooter is in position on the firing line and the target area is clear.
- Nocked arrows must always be pointed in a safe direction.
- Arrows must always be pointed downrange and below the horizon.
- Under no circumstances may a shooter point a nocked arrow above the horizon while drawing the bow.
- Anyone on either course may call a cease fire at any time. When a cease fire is announced, all bows must be brought to rest, arrows must be unnocked and safely stored, and shooters must step away from the firing line.
- Each shooting position has a corresponding target. Cross-shooting is not allowed.
- Archers must shoot only at the target provided.
- Under no circumstances may more than one arrow be nocked on the bowstring.

- Only one archer may nock an arrow at a time if more than one archer is at a station.
- If more than one archer is at a station, they must shoot in a line abreast. Do not shoot from behind another archer.
- When more than one archer is on the course, the last archer to arrive at the next station must contact the other archers before anyone begins shooting that station.
- Before drawing the bow, make certain the backstop and the area behind the target are clear.
- Before searching for arrows that miss a target, archers must hang their bows in front of the target.
- If a bow is hanging on a target, archers must not nock an arrow until that target area is clear.
- Both courses must be walked from start to finish. Once an archer enters a course, they must continue from start to finish. Backtracking is not allowed.
- Archers who deliberately shoot anything, but the range targets will be charged for damages and barred from club grounds.
- The club reserves the right to inspect all bows, arrows, and equipment brought onto club grounds.

Rifle / Pistol Range

Renton Fish & Game Club has 24 covered shooting stations on the pistol range, and 19 covered shooting stations on the rifle range.

Newly mounted scopes should be bore sighted and test fired at 50 yards to ensure the rifle is 'on paper' before shooting at longer distances.

Rifle/Pistol Range Safety Policy

- All firearms must be unloaded when entering RFGC property (except for concealed carry which must remain concealed). Concealed firearms are to always remain holstered on RFGC property. The Rangemaster must be notified if they wish to fire their concealed firearm.
Uniformed Law Enforcement are exempt from this policy.
- All shooters must sign in at the rifle/pistol rangemasters office BEFORE entering either the rifle or pistol range firing line areas or prior to bringing a firearm to the firing line.
- Members who arrive before a rangemaster is on-site SHALL NOT uncase their firearm until the Rangemaster or a Range Safety Officer arrives.
- ALL HANDGUNS on RFGC premises must be transported to the firing line, unloaded, magazines removed, and in a CASE. Uncased HANDGUNS are NOT ALLOWED to be moved or transported on to or off the firing line. If you do not have a case, speak with the rangemaster BEFORE removing the handgun from your vehicle and ask to borrow a case. Unreturned borrowed cases will incur a \$50 replacement fee.
- Eye and ear protection are mandatory on the rifle and pistol ranges
- Shooters should keep their fingers off the trigger until ready to shoot.
- Always point all firearms in a safe direction.
- Non-members are required to watch a range safety video prior to using the rifle and pistol range.
- Smoking is NOT ALLOWED under the covered areas of the rifle or pistol ranges. No smoking within 10 feet of black powder.
- All uncased firearms (excluding handguns) will be transported muzzle up, unloaded, magazines removed and chamber flags inserted, to, from and between shooting benches. No handling of uncased firearms during a cease fire.
- Only cased firearms may be brought onto the range during a cease fire.
- Club approved chamber flags must be used on the rifle and pistol range. If needed, non-members will be provided one as part of their daily fee. Members may purchase or use club provided chamber flags.
- Only uncase and case your firearm on the shooting bench, with the muzzle pointed downrange.

- Only one shooter and one loaded firearm is allowed per bench.
- Shooters will only shoot targets in the lane associated with the bench they are set up on. No cross-lane shooting without permission of the rangemaster.
- Shooters may fully load magazines but may only expend one round per second. Violations of this policy will limit the shooter to one round per magazine.
- In the event of a misfire, do not open the action of the firearm for at least 60 (sixty) seconds.
- If a firearm fails to function due to a jam, a squib, or other failure, keep the firearm pointed downrange and notify the rangemaster.
- When a shooter steps away from the firearm (i.e., is not in their immediate control) the firearm must have its action open, the breech clear of any ammunition, detachable magazines removed, and a chamber flag inserted .
- Shotguns are allowed on the 50- and 100-yard rifle range with lead slugs only and must be equipped with a buttstock and either:
 - An optic mounted on the shotgun or,
 - A front sight.
 Designated target frames for 'Shotgun use only' must be used.
- Black powder shooters must ensure that containers of black powder are closed before shooting to prevent flash explosions.
- Absolutely no rapid firing is allowed on either the rifle or pistol range.
- Shooters must not intentionally shoot into the baffle system, the lane markers, target board legs, the ground, or any other un-approved target.
- Picking up brass is not permitted unless the brass is your own.
- Place unwanted brass into the cans provided. DO NOT throw brass or live rounds in the trash cans
- 50 BMG caliber rifles allowed on the range.
- Only paper targets are allowed. Exploding targets are expressly forbidden.
- Special targets may be used on the rifle and pistol range only after coordinating with and having permission from the rangemaster. Permission must be received each time the target is used. An example of a special target is a sporting clay, "Rimfire Know Your Limits" Target, etc.. Special steel targets on the rifle range may only be shot with .22 LR with permission from the rangemaster.
- No steel targets are allowed on the pistol range (except for sanctioned events).
- No life-like silhouette targets are allowed.
- Rifle-caliber firearms such as .308, 5.56, 7.62 x 39, etc. are not allowed on the pistol range (this is not an inclusive list). If in doubt, talk with the rangemaster.

- Rimfire rifles (.22 or .17 caliber) are allowed on the 50-yard and 100-yard ranges. Use of rimfire rifles on the 200-yard rifle range is only permitted with prior approval from the Rangemaster.
- Club members may use the rifle and pistol ranges after 6:00 PM until 8:00 PM, Wednesday through Sunday. At least two people must be present, and one must be a member who is a Range Safety Officer (yellow badge). A cell phone is also required for emergency use. Members staying after 6:00 PM should coordinate with the rangemaster, sign in and sign out, and ensure that all lights are turned off and the front gate is locked before leaving.

Ceasefires

- Ceasefires are indicated by flashing red lights on the corresponding range.
- During a cease fire, all firearms must have their action open, the breech clear of ammunition, detachable magazines removed, and a chamber flag inserted.
- Firearms not on the shooting bench must either be in a case or, if uncased, be muzzle up, action open, the breech clear of any ammunition, detachable magazines removed, and a chamber flag inserted.
- All shooters must stay behind the red line and safety chains during any cease fire. During a cease fire the rangemaster will notify shooters when they may go down range to check targets or to set up support equipment.
- Shooters must not handle any firearm during any cease fire.
- Shooters may proceed down range to check targets only after a cease fire has been called, the red flashing light is turned on, and the all clear is given by the rangemaster.
- When using the 100-yard range, shooters must put up the orange cone on their way down range and lay it back down when returning.
- When using the 200-yard range, shooters must put up the orange cone on their way down range and lay it back down when returning.

200-Yard Steel Target Qualification and Procedures:

- The steel target at 200 yards may only be used by members who have qualified. To qualify, the member must coordinate with the Rangemaster and shoot a consecutive five-shot group on an eight-inch paper target at 200 yards.
- Steel target privileges do not extend to guests of qualified members.
- Steel is NOT intended to be used as a sight-in tool.
- Once qualified, the member's badge will have a star punched in it.

- Due to the additional cost of maintaining the steel and hangers, each qualified member must pay an initial \$25 fee and a \$25 annual fee at the time of membership renewal.
- The steel is checked out by the qualified member, through the rangemaster, (see sign-in/out sheets) and, when finished shooting the steel, must be checked back in to rangemaster. Targets must be repainted, and any repairs done. If repairs are beyond reasonable fixes, the shooter must notify the rangemaster of the damage .
- Once qualified, the member will be given access to the locked box where the steel is stored.
- If the steel target is in use, other qualified members may concurrently use steel at the discretion and approval of the member who originally checked out the steel. The member who originally checked out the steel has the right of refusal. If the member who checked out the steel allows other qualified members to use it concurrently, and cannot/does not bring steel back in, they must inform rangemaster they are turning the steel over to the responsibility of the other shooter and sign steel out of their name and into the name of the other shooter.
- All qualified shooters are responsible for watching who is shooting the steel and stopping non-qualified shooters from using the steel. If non-qualified shooters refuse to stop shooting the steel, notify the rangemaster who will talk to the non-qualified shooter and explain the rules of shooting the steel target.
- Failure to follow these rules may result in the loss of range and/or steel target privileges.

Pistol Range Ceasefire Process –

Certain lanes of the pistol range have motor-operated target retrieval systems that allow for uninterrupted target changes on the lanes so equipped. This requires all shooters to be considerate of those shooters who must go down range to manually change targets. The following rules apply for manual target changes:

1. Check with other shooters to coordinate a cease fire. The individual(s) initiating or requesting a ceasefire will become the Lead Safety Officer (LSO) during the remainder of that ceasefire.
2. LSO announce: Ceasefire!
3. LSO announce: Actions are open, the chamber is empty, detachable magazines are removed, chamber flags are inserted.
4. LSO announce: All shooters move away from the shooting bench and hang safety chains.
5. LSO walks the line to verify that each firearm's action is open, chamber is empty, detachable magazines removed and chamber flags inserted.
6. LSO verify all safety chains hung as appropriate.
7. LSO activates the red light and relocates downrange access chains to block off access to shooting lines.
8. LSO announce: "The range is cold; shooters may go forward to place or check targets".
9. Shooters going to the 50-yard line must raise the orange cone indicating that someone is down range. Upon return from the 50-yard line, the cone must be laid down.
10. LSO (the one who called the cease fire) verifies all shooters are back from downrange.
11. Only after all shooters are back, the LSO may move chains from the side of the shooting lanes to close the downrange access.
12. LSO turns off the red light and announces: "Range is now hot you may commence shooting".

Shotgun Range

Renton Fish & Game Club has five trap houses configured for American Trap, doubles, and Continental trap. The shotgun range also includes one skeet field. In addition, the club operates the only operational International Trap bunker in the Pacific Northwest and hosts challenging multi-station sporting clays shoots throughout the year.

Shotgun Range Policy

- Firearms on the shotgun range are limited to shoulder-mounted shotguns in 12, 16, 20, 28, and .410 gauge.
- Trap shooters are limited to lead shot sizes 7½, 8, 8½, or 9. Steel shot is not allowed.
- Skeet shooters are limited to size 9 shot only.
- Load only one round when shooting American Trap.
- Up to two rounds may be loaded when shooting Continental, doubles, skeet, or International Trap.
- Shotguns must always remain unloaded with the action open unless the shooter is on the line and ready to fire. A shell may be placed in the shotgun, but it may not be chambered, and the action may not be closed until it is the shooter's turn.
- Shotguns must be unloaded when changing stations.
- When changing stations, the person on station 5 must walk behind the other shooters to move to station 1.
- When shooting trap from handicap positions, no more than 2 yards may separate any two shooters.
- When carrying a shotgun, the action must be open, and the muzzle must always be pointed in a safe direction.
- Only clay targets supplied by the club may be used in club machines.
- Only qualified members may service club trap machines.
- If an orange safety cone or a "Trap Closed" sign is placed on top of any trap house, shooters must not enter that trap field or its shooting stations.
- Shooters must unload all shells from the shotgun when a cease fire is called.
- Only one shooter per line is allowed. Instructors and coaches must check with the rangemaster before standing on the line during any round.
- Only one shooter may shoot at each target, except during organized fun shoots.
- Do not pass shotguns between stations during any round.

- Any shooter asked to check their shotgun must unload it and visually inspect the barrel to ensure there are no obstructions.
- Shooters may pick up only their own shells.

Shotgun Range Restrictions

- Shot larger than size 7½ may not be fired on the shotgun range at any time.
- Slug guns are not permitted on the shotgun range.
- Non-shoulder-mounted shotguns are not permitted on the shotgun range.
- Shotguns with detachable box magazines are not permitted for trap or skeet.

Shotgun Safety Rules

- Everyone on the shotgun range must wear eye and ear protection.
- Shotguns must always be pointed in a safe direction.
- Keep your finger off the trigger until you are ready to call for a target.
- In the event of a misfire, wait at least 30 seconds before opening the action.
- In the event of a squib load, visually inspect the barrel and confirm there are no obstructions before continuing to shoot.

Action Bay Use

Renton Fish and Game has seven "Action" bays that are shared by all the action bay disciplines. There is a shared Thursday night practice session, where SASS, USPSA, ASI, and IDPA shooters can come in and use any range equipment. Participants must either be or coordinate with an RSO II.

To qualify as an RSO II the RF&GC member must be a current ASI, SASS, IDPA, Steel Dragon or USPSA Range Safety Officer. In addition, they must receive approval from the Discipline Chairperson of the sport that they participate in. Other Approvals must be reviewed by the Discipline Chairs.

The candidate must also go through a formal club sponsored orientation given by the discipline chairman or their designee.

After the orientation, they will receive a sticker for their badge from the Rangemaster for RSO II Qualification.

Renton members who are an RSO II can make use of the bays when there are no scheduled matches or other activities, but there is a strict set of rules that apply.

Use of the action bays:

During Steel Dragons practices, others may use the action bays but may be asked to leave if the Dragons need to expand their practice to that bay. Example: The RSO II sets up in bay 6, but the Dragons have so many kids show up that they also need that bay for their practice. Please note that Centerfire rifles are not allowed (it's hard to coach with the extra noise).

USPSA setup and matches - No use of the bays is allowed on Saturday. No use on Sunday until after the match is over and they have left the bays (approximately 4:00PM).

IDPA and ASI matches - No use is allowed until after the match is over and they have left the bays (approximately 3:00PM).

Rules for the Action Bays Use During Practice:

1. The bays are restricted to RF&GC RSO II's and their guests (guests may be members or non-members).
2. **There is NO shooting on Monday or Tuesday.** Start Time is the same as the Rifle range. **Shooting must end before 8:00PM.**

3. During normal operating hours, members and their guests must sign in at the rifle range and pay any applicable fees. If a RSO II has non-member guests, they must wait at the rifle range until an RSO II meets them there.
 - a. If the non-member arrives outside of regular hours, the RSO II is still responsible for collecting the required fees and waivers from their non-member guests, which must be submitted during the member's next visit.
 - b. Guests are not permitted to access the action bays until the RSO II is present.
 - c. Guests must be accompanied by and shoot with the RSO II who is responsible for their actions and must make them familiar with these rules.
4. At the Action Bays everyone must sign "In" and "Out" on the provided attendance Log.
5. Shooting may be conducted by one or more persons when an RSO II Badged Member is present, and all range safety rules are followed. This change is approved as a trial through March 1, 2027. An RSO II Badged Member shooting alone assumes responsibility for their own safety and should have a charged cell phone available in case of an emergency. Use by one person is at the member's discretion and does not waive any Club safety requirements.
6. Unsafe behavior or action must be reported by the RSO II to the rifle range Rangemaster.
The shooter deemed shooting unsafely is done shooting at RF&GC for the rest of the day.
7. Badges must be always worn while on RF&GC property.

Safety

1. Eye and ear protection must be worn by everyone.
2. A billed hat is recommended (due to shot falling into the bays from the Shotgun Range).
3. Firearms must enter and leave the area in a safe manner.
 - a. Firearms handling at the vehicles or in the parking areas is limited to holstering, casing and uncasing, and placing in or removing from carts or carriers. Aiming or practicing in any way is specifically not allowed.
4. In the Bays, the Loading Benches may be utilized as a Safety Area for gun handling as long as the muzzle remains pointed toward the berm behind the bench.
5. When loading and unloading, your finger must be out of the trigger guard! We recommend that the muzzle be pointed at the berm.
You are personally liable for negligent discharges. If a round leaves the bay, it is an unsafe action. The incident must be reported by the RSO II to the rifle range, Rangemaster. The shooter is done shooting at RF&GC for the rest of the day.

6. All targets (steel and paper) must be placed as close as practical to the berm. The intention is that rounds through the paper or missing steel will impact the berm rather than the floor of the bay.
7. Do not shoot rocks. Place your targets so that there are no large rocks in the impact area.
While doing target checks, re-setting or repair, visually look at the impact area & remove any rocks that are migrating to the surface.
8. Plate Racks are restricted to Bays 1 - 3.
9. **No** armor piercing, **No** tracer, **No** steel core ammunition.
10. Shotgun: 7 ½ or smaller Shot on Steel; Slugs & Buckshot on Paper ONLY.
No Shotgun on Plate Racks.
11. Centerfire rifles (up to 7.62 x 39) may only be used in Bays 1 - 3.
7.62 x 51 or .308 Win (or greater) is NOT allowed.
12. Do not shoot steel targets with any center fire, rifle-caliber (high power) rifles.
13. Steel targets are not allowed in bay 7 (exception is made for sanctioned matches).
14. Shoot only from within the confines of the bay.

Please help keep the area clean and tidy. Your cooperation is appreciated.

1. Remove all items (target bases, steel targets, barricades, walls, etc.) from the bay and return them to the proper storage locations.
2. Pick up all Live Rounds.
3. Pick up your shotgun hulls and all your garbage.
4. Picking up brass and steel cases is encouraged but not mandatory.
5. If you brought it in, carry it out.
6. Put all garbage into the dumpster by the Action Bay entrance.
